

Gift Aid

If you are a UK tax-payer, giving to Farleigh School with Gift Aid enables us to increase the value of your gift by up to 25%, at no additional cost to you. To make a Gift Aid donation, you must pay at least as much Income Tax and / or Capital Gains Tax as the amount of tax reclaimed by school. This is currently 25 pence for every pound donated. Higher-rate tax payers who make a donation through Gift Aid can claim some tax back:

Higher Rate Tax Payers and Gift Aid

Donors paying higher rate tax can claim the difference between the higher rate of tax (40 and/or 45 %) and the basic 20 % rate of tax on the total gross value of the donation. You can make this claim on your [Self Assessment](#) tax return by completing the section on Gift Aid payments. Otherwise, details can be given on form P810 Tax Review.

Gifts given over a number of years
